Mare Reproductive Contracts are a simple way for West Coast Veterinary Hospital clients to pay a one-off fee for routine reproductive work during the breeding season. The contract is effective from 1st August to 31st December, or until your mare is 45 days pregnant in the 2025 stud season. Mare Contracts are not mandatory however, should you wish to put your mare(s) on contract please be aware of the following conditions:

- **1.** Mares starting reproductive veterinary work in August and September, must be on the contract before 7th October 2025. After this date, a late fee of \$50 (per month that the work was accrued), will be applied to the account, if the contract is approved.
- 2. Mares starting reproductive work after 7th October are eligible for a reproductive contract for 45 days from the 1st of the month that the work commenced.
- 3. Payment for mare contracts is required upfront. The contract will not be executed until the contract fee is paid in full.
- **4**. The contract fee is non-refundable, even if the mare obtains a positive pregnancy scan in the first cycle or on the first cover.

Please note that not all charges relating to mare reproduction are covered under the terms of the Reproductive Mare

Contract. Please take the time to read the inclusions and exclusions which are listed in the contract paperwork.
